Dean's measure No 1/2015–2016

Title: **Definition of the Relevant Entity and Research Infrastructure at the Faculty of Medicine of the Charles University in Hradec Králové**

To perform: Article 5 of Rector's measure No. 40/2015 Economic and non-economic activities at Charles University in Prague, which amended Rector's measure No 6/2015 Economic and non-economic activities at Charles University in Prague

Effectiveness: 1st January 2016

**Article 1
Initial Provisions**

The Measure defines the relevant entity and research infrastructures within the Faculty of Medicine of Charles University in Hradec Králové (hereinafter ‘the LF’).

**Article 2
Definition of Relevant Entity**

1. This Measure defines the relevant entity of the LF as a whole.
2. The relevant entity (hereinafter ‘RE’) is defined as a separate organizational entity that is able to dispose effectively of the assets and other resources assigned to carry out independent basic research, industrial research or experimental development, or the public dissemination of the results of such activities in the form of teaching, publications, transfer of knowledge, i.e. the activities defined in point 19 of the Framework for State aid for research and development and innovation (hereinafter ‘the Framework’). The LF as RE has the possibility to effectively dispose of and use assets, material, human and other resources when carrying out a primary activity relatively separately or transferring knowledge in accordance with point 19 of the Framework.
3. In the event that an economic activity is carried out by the RE alongside a non-economic activity, the economic activity must be of a purely ancillary nature and be carried out to a limited extent. All economic activities carried out by the LF must be directly related to the operation of the RE and must be necessary for its operation or inseparably linked to its main non-economic use, i.e. its activities must fall under point 19 of the Framework and be limited in scope (RE's capacity to use resources for economic activities must not exceed 20 % of the total annual RE capacity).

**Article 3
Definition of Research Infrastructures**

1. Research infrastructure will not be defined for the conditions of the LF.

2. In the event of the establishment of centres operated under the OP VaVpI (Operational Programme Science and Research for Innovation), or the implementation of projects incorporated in the Czech Republic's Travel Map of Major Infrastructures, possibly the projects of OP PK (Operational Programme Prague Competitiveness), NPU (National Heritage Institute), etc., the research infrastructure will be determined by the appropriate Dean's measure.

Article 4 Final Provisions

1. LF as a RE, or future research infrastructures, always act in accordance with the relevant regulations.
2. This Measure shall take effect on 1st January 2016.
